For the avoidance of any doubt, although our members and some of our employees and consultants are referred to as "partners", they are not all members of the LLP. 1. Acceptance

Your use of the Website is subject to the following Terms & Conditions, which you are deemed to accept by using the Website. If you do not agree to these terms, you must not use our site.

2. Copyright

The copyright and all other rights in the material on the Website are owned by us or are included with the permission of the owner of the rights. As a visitor to the Website, you may download a single copy of the material on the Website on a single computer for your own private viewing/listening purposes only. Single copies of pages from the Website may be printed out for the sole purposes of enabling the person printing the page to retain a copy for their own personal records.
